Official Rules and Regulations

1. Min: 8 Max: 10 people play on the field. A minimum of 3 girls must be on the field at all times. You may arrange them in any manner that you choose as long as there is a pitcher and a catcher. The catcher must play behind home plate. The pitcher must stay on the spot designated as the pitcher's mound. No encroaching! **No player may be closer to the kicker than the pitcher. Players must be even to or behind the pitcher.**
2. All games will be 5 innings.
3. Each person who played in the field must bat once before a player may bat a second time in an inning. In other words, you must follow a batting rotation each inning. You must bat guy, girl. Two girls may bat consecutively, but two guys may not bat consecutively. If you break this rule you will be assessed an automatic out immediately when caught!
4. There is absolutely, positively **no stealing bases at any time.** You will be called out if attempting to steal and/or if your foot is not on the base up until the time when the kicker strikes the ball. **No leading off or leaving before the ball is kicked!**
5. Fielders may throw the ball at or below a base runner's shoulders for an out. Hitting anyone in the face or head results in an automatic 2 bases for each base runner. **However, if the runner ducks or throws his or her head into the line of the ball intentionally, no extra bases will be awarded.**
6. Pitchers: The pitch must be rolled into the kicker's box or it will be called a ball. 4 = walk; 3 foul balls = out! No strike-outs
7. Kickers: The kicker is only permitted one touch on the ball (ie: you cannot trap it once and then kick it, obviously!) You must kick the ball (a)while it is still moving and (b) when it is in the kicker's box at home plate.
8. Tagging up is permitted. However, the infield-fly-rule is NOT in effect. Yet, know that it is considered bad sportsmanship if a fielder intentionally drops a ball in order to lure the runner off the base in an attempt to turn a double play. Please, don't do that.
9. Sliding is permitted. Please be smart. The church is not responsible for any injuries sustained while on the premises.
10. **BUNTING IS PERMITTED**
11. Foul language and poor sportsmanship is not permitted. We want everyone to have fun, but remember that this is a Christian event, and you are representing your church and youth group. Any player in violation of this rule will be removed from the game.

KICKBALL TOURNAMENT WAIVER RELEASE FORM

The "Youth Kickball" participants and parent must sign this liability waiver. Any individual whose signature does not appear on this form will not be permitted to participate, and therefore, disqualifies that individual from the event.

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO INDEMNIFY AND HOLD HARMLESS

In consideration of entry into and participation in the activities associated with the Temple Baptist Church, Baldwinsville, NY and in recognition of the risk of injury while participating in the kickball tournament and as consideration for the right to participate in the activities, I hereby for myself, my heirs, executors, administrators, assigns, or personal representatives knowingly and voluntarily enter into this WAIVER and RELEASE OF LIABILITY and hereby WAIVE any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation and do hereby RELEASE and forever discharge Temple Baptist Church, Baldwinsville, NY and their members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, the event site and its agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns and all sponsors and/or beneficiaries of the Kickball Tournament from any and all liability, claims, demands, damages, actions or causes of action of every kind and character now existing or which hereinafter may arise as a result of my participation regardless of cause or whether any injury is caused by the sole, joint, comparative, or concurrent negligence or gross negligence or fault of the kickball Tournament, the negligence or fault of myself or third parties, the conditions of the event site or any other cause.

Further and for the consideration herein described, I agree to INDEMNIFY and HOLD HARMLESS the Kickball Tournament against any and all claims, demands, damages, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought y me or anyone on my behalf, including attorneys fees, if litigation arises on account of claims made by me or anyone on my behalf caused by negligence, gross negligence, negligence per se, strict liability and/or liability under the Deceptive Trade Practices Act or other fault regardless of cause or whether caused by the sole, joint, comparative, or concurrent negligence, gross negligence or fault of the Kickball Tournament, my own fault or the fault of third parties, the conditions of the event site or any other cause. To INDEMNIFY means to assume the liability in a situation, thereby relieving the other party of responsibility. I hereby declare that I have read and fully understand this Agreement in its entirety and that, by signing below, I assent to the terms and conditions contain this Agreement.
